Parental Involvement meetings will be held at various times and days throughout a normal school year. Flexible times for parent meetings are planned according to the parents' survey data. The survey is conducted annually. Virtual meetings via Google Meet are offered each Wednesday and when warranted. The school will schedule the annual meeting to inform parents of Title I participation. Our goal each year is to increase parent participation. We try to offer a variety of reasons for parents to be involved. Some of these activities will include the entire school and are flexible as to day and night functions and virtually. Parents are asked to serve on a Parent Advisory Committee. Parents will have the opportunity for input and feedback through Parent and Family Engagement meetings along with multiple PTO meetings throughout the school year. Funds are used to provide parents with materials that can be used to assist in supporting their student's academic needs. In addition, funds are used to purchase flashcards, pamphlets, and other resources for parents to use at home with students.

Teachers send home curriculum information weekly for parents and students. STAR/Early Literacy, Dibels, and Performance Series reports are shared with parents after each benchmark assessment period. Parents are encouraged to stay in close communication with teachers through notes, phone calls, virtual meetings, and conferences, as well as monitoring information on INOW, and through weekly folders/graded papers. In addition, a Title I meeting is held annually to inform the parents of Title I plans and instructional programs. To accommodate parents' busy schedules, the meeting is made available for parents to view on the school's web page. The school counselor's office is equipped with books, pamphlets, videos, games and other resources to support positive interactions between parents and children. Incoming kindergarten parents are given bags with resources to help with their transitioning students. Lists of educational websites and login information are also provided for parents. Social media avenues are also used to keep parents informed of LCES events.
